

## CITY OF RIVERVIEW

### PEDDLERS LICENSE

A 'PEDDLER' IS ANY PERSON WHO GOES FROM PLACE TO PLACE, TRAVELING BY FOOT, WAGON, CAR, ETC, OFFERING THE GOODS THEY ARE CARRYING FOR SALE. THIS INCLUDES HAWKERS, HUCKSTERS and ICE CREAM VENDORS.

<b><u>FEES:</u></b>	License	<b>\$200.00 per day</b> (maximum of \$2,000.00 per year)
	Investigative fee	\$ 75.00 per person
	Fingerprinting	\$ 15.00 per person
	I.D. Cards	\$ 1.00 (3 required)

**The Non-Refundable \$75.00 Investigation Fee and the \$15.00 Fingerprinting Fee** are due at the time of application. Applicant must make an appointment with the Detective Bureau for fingerprinting at 734-281-4215.

### REQUIREMENTS:

- A:** Copy of the proof of insurance, registration and a description of each vehicle to be used together with a copy of each driver's license. Ice cream trucks and some other vehicles may require a police inspection.
- B:** Three (3) recent photographs of the applicant, taken within sixty days of filing for badges. A badge is \$1.00 and must be worn at all times when working within the City. The photographs should be a 2" x 2" and should be a clear likeness of the applicant.
- C:** A Police Investigation and Fingerprinting will be done on all members of the group.
- D:** A brief description of the nature of the business and the goods to be sold.
- E:** Name and address of employer and proof of employment.
- F:** A list of dates the licensed peddler will be in the city.
- G:** The name, address and phone number of two property owners or residents of the city who will vouch for the applicant's character.

### RESTRICTIONS:

- 1:** Peddlers do not have exclusive rights to any location in the public streets and are not permitted a stationary location.
- 2:** Peddlers cannot operate in a congested area where his operations might impede traffic and inconvenience the public.
- 3:** Peddlers cannot use loud speakers, sound amplifiers, blow horns, ring bells or use any other sound device on any street, alley, park or public place in the City.
- 4:** The City Clerk's Office will maintain a record of each license and keeps track of all violations of the rules including those brought to our attention by surrounding cities.
- 5:** A Peddler's license cannot be used by anyone other than the original applicant and must be shown to any citizen of Riverview or any police officer upon request.
- 6:** If an applicant's license is denied, a written notice specifying the reasons will be given to the applicant. The applicant then has 10 days to file a written request for a hearing with the City Clerk's Office. The City Manager will set a time and place for a hearing.
